PRESS RELEASE – March 05, 2013:

1. **Misdemeanor - DUI:** On February 26, 2013, at approximately 5:30 PM, Corporal William Litterio and Patrolman Steven Gravier arrested **Anthony Davies**, age 29, of 4 N. Joseph Street, Westerly, RI on a charge of *Driving Under the Influence of Alcohol and/ or Drugs (1st Offense - BAC Unknown)* after a motor vehicle stop by Corporal Litterio on Main Street in Richmond. Mr. Davies was processed and released with a summons to appear for arraignment in 4th District Court on the above charge.
2. **Misdemeanor - Possession of Marijuana (1st Offense):** On March 1, 2013 at approximately 7:20 PM, Corporal William Litterio arrested **Dina L. Payne**, age 45, of 28 Buckley Avenue, West Warwick, RI, on charge of *Possession of Marijuana (1st Offense)* after a motor vehicle stop on Kingstown Road. Ms. Payne was processed at the station and was subsequently released with a summons to appear on March 28th, 2013 in 4th District Court for arraignment on the above charge.
3. **Misdemeanor - DUI (BAC Unknown) & Refusal to Submit to a Chemical Test:** On March 1, 2013 at approximately 9:30 PM, Corporal William Litterio arrested **Denis Messinger**, age 42, of 486 Moonstone Beach Road, South Kingstown on charges of (1) *Driving Under the Influence of Alcohol and/ or Drugs (1st Offense - BAC Unknown)* and (2) *Refusal to submit to a Chemical Test*, after Corporal Litterio stopped his vehicle for crossing over the center dividing line and driving eastbound in the westbound lane of Church Street towards Corporal Litterio's cruiser. Mr. Messinger was processed and released with a summons to appear for arraignment in 4th District Court on the above charge.
4. **Misdemeanor - Motor Vehicle:** On March 3, 2013 at approximately 8:30 AM, Patrolman John Randall arrested **Richard Smith**, age 36, of 758 Gardner Road, Exeter, on a charge of *Operating without a License (Expired)* during a motor vehicle stop on Gardiner Road, after learning that Mr. Smith's RI license had expired over a year earlier in January 2012. Mr. Smith was processed and released on a summons to appear in 4th District Court on April 4th, 2013 for arraignment on the above charge.

5. **Misdemeanor - Motor Vehicle:** On March 3, 2013 at approximately 9:00 AM, Patrolman John Randall arrested **David Kenney**, age 25, of 23 Valerie Drive, West Greenwich, on a charge of *Operating with a Suspended License* during a motor vehicle stop on Gardiner Road. Mr. Kenney, whose license was suspended on February 28th, 2013, was processed and released on a summons to appear in 4th District Court on April 4th, 2013 for arraignment on the above charge.

6. **Bench Warrant:** On March 4th, 2013 at approximately 5:30 PM, Patrolman Steven Gravier arrested **Robert J. Stanko**, age 29, of 299 Carolina Nooseneck Road, Richmond, after a motor vehicle stop on Main Street revealed that he had an outstanding **4th District Court Bench Warrant** that had been issued on March 1st, 2013, for *Failure to Appear* on an original charge of *Operating on a Suspended License* (RI State Police Hope Valley Barracks). Mr. Stanko was processed at the station before being arraigned by Justice-of-the-Peace Michael Robinson, and was released after posting the requisite surety bail of \$4,120 or the cash equivalent of \$412 (10% in cash).
